

One of the key benefits of rotating ads is that it helps prevent banner blindness. Banner blindness refers to the phenomenon where users become accustomed to seeing the same ad repeatedly and eventually ignore it.

By introducing variety through rotating ads, the chances of capturing users' attention increase significantly, as each new ad offers a fresh view and message.




